SECTION-3 **HAZARD IDENTIFICATION**

Causes eye and skin irritation. Inhalation can cause irritation to the respiratory tract and can result in chemical pneumonitis if aspirated. SECTION-4

FIRST AID MEASURES

ACCIDENTAL RELEASE MEASURES

Clean contaminated floors and objects thoroughly, observing environmental regulations If contamination of drains, streams, watercourses, etc. is unavoidable, warn the local water authority.
