SECTION-4

FIRST AID MEASURES

ACCIDENTAL RELEASE MEASURES

Clean contaminated floors and objects thoroughly, observing environmental regulations if contamination of drains, streams, watercourses, etc. is unavoidable, warn the local water authority.
